Board Summary

The MO Board of OT was created by Senate Bill 141 in 1997

The mission of the Missouri Board of Occupational Therapy is to protect the citizens of the state through the licensing of occupational therapists and assistants, assessing their competence to practice.

It is also the Board's duty to investigate all complaints against its licensees in a fair and equitable manner.

Six members: 3 OTRs, with at least 5 years of experience; 1 OTA; 2 public members.

Members are appointed by the Governor with advice and consent of the Senate.

Duties of the Board

Developing, Implementing and Administering the rules and regulations necessary to carry out the OT Practice Act.

These regulations include:

- Establishing the requirements for licensure
- Continuing competency
- The ethical standards of conduct for occupational therapy practitioners

The Board will also be responsible for investigating complaints related to the practice of occupational therapy.

Protect the PUBLIC - Ensure that the citizens of MO receive the highest quality OT services possible and that the profession develops in a manner that is productive for its practitioners and the state of Missouri.

How the board works

Quarterly meetings

• Need 4 members present to have a quorum

Meetings are OPEN and Closed

Open meetings are posted on the website and open to the public as are the records of those meetings.

Closed Meetings

- · Board discussion of disciplinary complaints
- Disciplinary interviews / testimonies

Legal Counsel is present at ALL meetings...open and closed

The Board adheres to the Missouri Sunshine Law regarding minutes and communication

What does the Board Do?

Staff/Board can't interpret state laws and regulations.

Actions by the Board:

- In the past year, the board amended the Continuing Competency rules
- Currently the Board is working on amending the OTA supervision rules

The Board DOES NOT advocate for the profession • That is the role of MOTA, AOTA and educational programs

For any rule or regulation change, there will be a 30 day public comment period. Licensees are encouraged to submit written comments

Continuing Competence (CCC's)

24 hours due every 2 year cycle

Random Audits are conducted by the Board following renewal ° Board members are currently completing the 2019 audits

Documentation

The rules explain how CCC's are prorated if you get a new license during a cycle. • The CCC Activities were updated by the Board in 2018

Complaints

Board reviews every complaint received.

Complaints must be made in writing

Licensee is given ample time to respond, in writing, to the allegations.

Board reviews response and determines next step of action.

Licensee and complainant are notified of final disposition.

Complaints are not public record, however, disciplinary action is public.

Disciplinary Actions

Licensee given opportunity to respond to allegations

Board reviews all documentation from both parties and makes a final decision

Censure, Probation, Suspension or Revocation (any combination)

All litigation is done by the Office of the Attorney General





National Licensure Initiatives

Licensure Compacts and Portability

 AOTA has signed a multi-year contract with the Council of State Governments (CSG) National Center for Interstate Compacts to create an interstate professional licensure compact for occupational therapy. This initiative is in response to licensure portability questions. The Occupational Therapy Licensure Compact legislation must be passed into law in each state where it will apply. The goal is to begin state participation by 2024.

o AOTA and NBCOT are also joining forces for this initiative

First Phase - August 2019–June 2020

Launch research project

Develop and convene advisory group

Initial meeting is Oct. 29-30

 One of our board members (J Dallas) has been asked to be on the advisory group Develop drafting team to develop compact language Circulate compact draft for review


An interstate licensing compact would:


 Allow licensed occupational therapists and occupational therapy assistants to practice across state lines (e.g., telehealth)


- Improve consumer access to occupational therapy
- Enhance mobility of occupational therapy practitioners (e.g., spouses of relocating military families, staff of travel therapy companies)
- Improve continuity of care
- Preserve and strengthen the state licensure system
- o Enhance the exchange of licensure, investigatory, and disciplinary information between member states.

An interstate licensing compact would not change state occupational therapy practice acts or the scope of practice.
